### Information

### Which data do we receive from you, and what do we use them for?

In order for you to be able to enter into a contract of tenancy agreement with the landlord (Article 6(1)(b) of the Regulation), and in order for us to be able to fulfil our obligations, we will receive your identification and contact details, i.e. the name, address, telephone number, email address and date of birth (or business reg. no.) of you as the tenant, and similarly if you are the holder of a power of attorney, an authorised signatory or representative of the tenant. For the purpose of living up to our consultancy liability, we will store these data and the correspondence in the case for up to ten years after the case has been completed.

In order for us to be able to meet our obligations under the Money Laundering Act, we will receive your civil reg. no. (CPR) and further verification data (such as proof of identity) in addition to your contact details. These data will be used for the customer due diligence procedure we are required to conduct. We are subject to a duty to report which means that your personal data may be disclosed to public authorities. We will store the data about you which are only relevant to the obligations under the Money Laundering Act for five years after the case has been completed.

We will also disclose your identification and contact details and may disclose other necessary data from our agreement and correspondence when we obtain data from other sources than from you. Please see below.

### Consents

We need your consent to our processing of your personal data if we are not obliged to obtain them under legislation or agreement (see Article 6(1)(a) of the Regulation). We therefore ask you to consent to the following:

#### Consent to the processing of your civil reg. no. (CPR).

In order for the real estate agent to be able to identify you sufficiently, they need your civil reg. no. in addition to the identification data defined above. The civil reg. no. will not be made public. It will only be shared with advisers, public authorities, For example, the property administrator at any time, involved in the real estate agent's case administration before, during and after a sale when this is required. The real estate agent and the mentioned players will keep the civil reg. no. for as long as is necessary. The data will be erased subsequently.
